

Public Realm Improvement Works to Cathedral Street and Sackville Place

Dublin City Council are proposing public realm improvement works to Cathedral Street and Sackville Place.

The proposals include:

- The removal and replacement of the existing asphalt and concrete road surfaces with a new paved granite carriageway, to include loading bays, disabled parking and taxi ranks.
- Existing asphalt, concrete and paved footpaths are to be removed and replaced with new granite flags, while retaining areas of historic paving and kerbs.
- The removal of the existing street furniture and replacement with new street furniture, tree planting, seasonal planting containers and seating.
- Changes to existing traffic movements on Cathedral Street are proposed in tandem with the proposed public realm improvement works and the recently completed LUAS Cross City works.
- The proposals include all necessary service, utility and associated site works.
- The works will be programmed such that businesses can remain open and disruption is minimised.
