## Park West - Cherry Orchard Local Area Plan

Dublin City Council is preparing a new Local Area Plan (LAP) for the Park West-Cherry Orchard area. The Park West-Cherry Orchard Local Area Plan will guide how the area will develop over time, the types of development that will be encouraged and where these should be located. The LAP will also look at things like how easy it is to travel around the area, the quality of public spaces and the design of future buildings.

Public consultation is an integral part of the Local Area Plan process. An issues paper has been prepared for Park West-Cherry Orchard in order to stimulate public debate and to provide the public with an opportunity to identify the 'issues' of concern, prior to commencement of the preparation of the Draft Local Area Plan. To assist this process, Dublin City Council is inviting submissions from the public on issues which the plan should address.

The issues paper is an early and important step in the process, and is undertaken before the preparation of the draft LAP to ensure that local issues are identified at an early stage and inform the preparation of the draft plan. The purpose of this paper is to pose a series of questions under a number of themes to prompt ideas on the types of issues that the plan should address. The Council is consulting with the local community now before a Draft Local Area Plan is prepared.

All submissions and observations received by 16th March will be taken into consideration during the preparation of the Draft Park West-Cherry Orchard Local Area Plan. Submissions and observations should state the name, address, and where relevant, the body represented. Children, or groups or associations representing the interests of children, are entitled to make submissions or observations.

A Draft Local Area Plan will be prepared for further consultation at a later stage and this will be accompanied by an Environmental Report prepared as part of a Strategic Environmental Assessment. The Draft Local Area Plan will also be subject to an Appropriate Assessment Screening under the Habitats Directive (92/43/EEC).
