## **Context:**

Public Participation Networks across Ireland currently have a wide variety of logos. The current initiative to communicate the role and benefits of Public Participation Networks has considered the logos and offered solutions to the Networks that will enable greater consistency and effectiveness in our messaging at both national and local levels.



# **Option 1: Current Logo A**

All Public Participation Networks will retain their current logo designs. This option is not recommended as it will not support messaging at a national level. It will result in the image of Public Participation Networks as an adhoc patchwork of initiatives across the country.



# **Option 2: Current Logo B**

All Public Participation Networks will retain their current logo with a shared typeface and naming system. To create a consistent look nationally, each logo will fit within a shared design (some examples below). This option allows for individuality between Networks while communicating that this is a national, co-ordinated initiative.



# **Option 3: New Logo A**

All Public Participation Networks adopt a new shared logo design. This circular motif has been developed from the current designs of individual networks. Local Public Participation Networks will each have their own, based on county colours (some examples below). The networks together will be represented by a multi-coloured version. This is the recommended option as it creates a strong visual connection between individual Public Participation Networks while building a national identity.



## **Option 4: New Logo B**

All Public Participation Networks adopt a new shared logo design. This intersecting disk logo has also been developed from the current designs of individual networks. Local Public Participation Networks will each have their own, based on county colours (some examples below). The networks together will be represented by a multi-coloured version. This is the recommended option as it creates a strong visual connection between individual Public Participation Networks while building a national identity.
